### ANNUAL REPORT FOR THE YEAR 2018-19

Blind Persons' Association, (B P A) Mumbai is a voluntary charitable organization working since October 1947 for the betterment of blind individuals residing in Mumbai and its suburbs, and surrounding districts including Thane, Palghar and Raigad, with focus on the needs of non-institutionalized blind persons.

The Executive Council of BPA presents with great pleasure the Annual Report of its activities for the year 2018-19:

### MEMBERSHIP

The present strength of membership is 1085, including 13 new members admitted during the year.

### **COMMITTEE MEETINGS**

During the year, the Executive Council met 4 times and the Working Committee met 5 times. We are happy to note that the committee members had active participation in the meetings. They gave their valuable suggestions and efficiently undertook the tasks assigned to them.

### ANNUAL GENERAL BODY MEETING

The 71st Annual General Body Meeting of the Association was convened on Saturday, 8th September 2018, at Smt Kamla Mehta Dadar School for the Blind, Dadar (East) Mumbai, which was attended by 81 members.

### **ACTIVITIES**

BPA has many programmes and schemes like Scholarship and Educational Assistance, Help the Aged, Medical Assistance, Need Based Financial Assistance, House Repair, sale of Aids and Appliances at subsidized cost, Counseling Services, etc. It also organizes functions, cultural programmes like Reshimbandh (which is specially meant for visually impared youth), Hawkers' Day, Foundation Day, Annual picnic, Women's Day etc.

### Details of these are as under:

### MEDICAL ASSISTANCE:

BPA has a Medical Assistance Scheme under which an amount of Rs. 51,015/- was disbursed during the year to 22 beneficiaries. It covers the expenses incurred on clinical tests, treatment of ailments, purchase of medicines, surgery etc. The Association decides the quantum of assistance based on the production of appropriate medical documents. Considering the rising cost, the Association has set up a Medical Corpus Fund during the Financial year 2010-11 and as on 31st March 2019, it stands at Rs. 10,37,064/-which include the donations of Rs. 60,000/- received during the year 2018-19. We aim to raise this as much as possible and the interest accrued on the same is utilized for the purpose of providing medical assistance to the needy We are extremely happy to announce that donors and blind people. well-wishers, sighted as well as blind are responding generously to our appeals and we would urge more and more people to come forward and donate for this purpose.

### **EDUCATIONAL PROGRAMME**

BPA has two schemes to promote education amongst SIGHTED children of BLIND parents

- Free distribution of school materials for Pre primary & Primary School going children.
- Educational Assistance in the form of Scholarship to the children studying from primary to higher education and vocational training.
- BPA also offers educational Assistance to College Going BLIND students

On Saturday, 16th June 2018, BPA distributed school materials . to the sighted students of blind parents. The Note Books were sponsored by Mr Hitesh Mehta of H M Classes who has been sponsoring the same for the past 12 years through the kind courtesy Mr Purshottam Patel and the Water Bottles were sponsored by Mr Naresh B Thakur, Member, through the kind courtesy of Mrs Anubha Dixit. The Pencil Boxes, Compass, scales etc were given as donation by Mr. Prasad Todankar and a cash donation of Rs. 3,000/- was received from the Q C S C Staff members of Mazgaon Telephone Exchange of Mahanagar Telephone Nigam Ltd. for purchase of educational materials. Both these donations were received through the efforts of Mrs Savita Zende, our staff member. The Association kept on record its sincere thanks to all the donors for their valuable assistance.

Seventy three sighted children of 60 blind parents were assisted to the tune of Rs, 20,032/-for educational materials.

Scholarship worth Rs.70,400/- was distributed by way of cheques on Saturday 1st December 2018, to 110 sighted children of 81 blind parents and also an amount of Rs.71,100/- was distributed by way of cheques as Scholarship to 64 college-going blind students, Saturday, 19th January 2019, at the BPA Office, Cottongreen.

Thus under the educational programme, during the year Association spent a total amount of Rs.1,61,532/-.

# BPA-BPCL SCHOLARSHIP

During the academic year 2018-19, we referred 19 sighted school and college going wards of blind parents, to Bharat Petroleum Corporation Ltd., for scholarships. Due to some technical reasons at their end, the scholarship amount was not distributed till the end of March 2019. We were informed that the BPCL would disburse the amount tentatively in The Association kept on record its the month of April/May 2019. sincere thanks to BPCL for their consistent support to our cause.

# NEED-BASED FINANCIAL ASSISTANCE

Under this scheme, BPA offers partial financial assistance to needy blind persons to acquire household articles such as Cots, Mattresses, Gas connections, Cupboards, Kitchen Racks, Utensils etc. BPA also provides financial assistance to needy blind persons to meet unforeseen expenditure caused by fire, flood, building collapse, sudden death of earning member of the family etc. Total assistance of Rs 20,202/- was disbursed to 10 clients during the year.

### HOUSE REPAIR

BPA extends a helping hand to the needy blind persons residing in hutments and dilapidated dwelling units to get their houses repaired. The help is given in the form of building materials. assistance of Rs.24,000/- were provided to 12 beneficiaries in the year under review.

# HELP THE AGED SCHEME

Under this scheme we give Rs. 500/- per month per person, to financially poor blind persons who have reached the age of 60 or older to meet part of their expenses for medicines, grocery, toiletries, clothes etc. This aid is provided at their doorsteps, which builds up good rapport with them. During the year, 20 males and 14 females were assisted to the tune of Rs.1,98,500/-.

### **EQUIPMENT BANK**

For last several years BPA has been running Equipment Bank for the blind. This is a unique scheme of its kind in Maharashtra. Special aids and appliances such as White Canes, Chess Boards, Playing Cards, Writing Slates, Signature Guides, Weighing Scales etc. are made available at highly subsidized cost to needy clients. During the year the materials worth Rs. 12,185/--were supplied to 78 poor and needy blind persons.

# BPA THACKERSEY FUND FOR THE REHABILITATION & EMPOWERMENT OF BLIND WOMEN

BPA has established this benevolent fund for rehabilitation of blind women with kind courtesy of Thackersey Charitable Trust. During the year 2018-19, blind women were assisted in their hour of need under our various schemes to the tune of Rs 2,00,050/-. .

### HAWKERS' DAY:

The 8th Hawkers' Day was celebrated on Saturday 12th May 2018, at Kedarnath English High School, Nehru Nagar, Kurla (East) from 2.00 p.m. onwards. Dr Khatri, of K E M Hospital, Mumbai was the Chief Guest and Lion Deepak Rohra the Trustee of Kedarnath School was the Guest of Honour. Total 81 persons, including office bearers had participated in the function. The president welcomed the gathering . Dr Khatri, delivered a lecture on various health problems, especially diabetes and related illness. Four selected visually impaired hawkers viz. Mrs Malti Tamhankar, Mr Prakash Gurde, Mr Phoolchand Bomble and Mr Arun Dagde were felicitated with mementos at the function at the hands of the Chief Guest. The Association conducted a Chess Tournament for the blind and low vision people staying in Greater Mumbai and surrounding areas, on Saturday, 25th August, 2018, at our office premises, in collaboration with Lions Club of Juhu, under the auspices of Lions Juhu Smt Mohandai Oswal Eye Care Foundation from 10.30 a.m. onwards. Anubha Dixit, President and other office bearers of the Association along with Lion Raj Wankawalla, President, Lion Prajesh Nanvati, Hon. Treasurer, Mr Riddhish Shah, Chairman, Sight First, Lions Club of Juhu, were present on the occasion. The function started by lighting the lamp at the auspicious hands of Lion Wankawalla, President, Lions club of Juhu and Mrs Anubha Dixit President of the Association. Mrs Dixit welcomed the members and requested Mr Ketan Kothari, Hon. General Secretary, to introduce the Association to the guests. explained various activities and services being offered by Association for the overall empowerment of visually challenged people, for more than seven decades. He also said that this is the first time we are conducting a chess tournament for the visually challenged people project jointly conducted by the BPA and and this is also the first Lions Club of Juhu. We would look forward for having more and more innovative projects with the help of Lions Club, in the years to come. ### FREE DISTRIBUTION OF FOLDING CANES:
