ANNUAL REPORT FOR THE YEAR 2019-20

BlindPersons' Association, (B P A) Mumbai is a voluntary charitable organization working since October 1947 for the betterment of blind individuals residing in Mumbai and its suburbs, and surrounding districts including Thane, Palghar and Raigad, with focus on the needs of non-institutionalized blind persons.

The ExecutiveCouncil of BPA presents with great pleasure the Annual Report of its activities for the year 2019-20.

MEMBERSHIP

The present strength of membership is 1094, including 9 new members admitted during the year.

COMMITTEE MEETINGS

During the year, the Executive Council met 5 times, including a Special Executive Council meeting and the Working Committee met 4 times. We are happy to note that the committee members had active participation in the meetings. They have given their valuable suggestions and efficiently undertook the tasks assigned to them.

ANNUAL GENERAL BODY MEETING

The 72nd Annual General Body Meeting of the Association was convened on Saturday, 28th September 2019, at Kedarnath English High School, Nehru Nagar, Kurla (East), which was attended by 64members. In that meeting other business important amendment to the rules and regulation of the association were carried out. These will alter the working of the association in the near future.

ACTIVITIES

BPA has many programmes and schemes like Scholarship and Educational Assistance, Help the Aged, Medical Assistance, Need Based Financial Assistance, House Repair, sale of Aids and Appliances at subsidized cost, Counseling Services, etc. It also organizes functions, cultural programmes like Reshimbandh (which is specially meant for visually impaired youth), Hawkers' Day, Foundation Day, Annual picnic, Women's Day etc.

Details of these are as under:

MEDICAL ASSISTANCE:

BPA has a Medical Assistance Scheme under which an amount of Rs. 62,770/- was disbursed during the year to 30 beneficiaries. It covers the expenses incurred on clinical tests, treatment of ailments, purchase of medicines, surgery etc. The Association decides the quantum of assistance based on the production of appropriate medical documents. Considering the rising cost, the Association has set up a Medical Corpus Fund during the Financial and as on 31st March 2020, it stands at 10,82,064/-which includes the donations of Rs. 45,000/- received during the year 2019-20. We aim to raise this as much as possible and the interest accrued on the same is utilized for the purpose of providing medical assistance to the needy blind people. We are extremely happy to announce that donors and well-wishers, sighted as well as blind are respondinggenerously to our appeals and we would urge more and more people to come forward and donate for this purpose.



EDUCATIONAL PROGRAMME

BPA has two schemes to promote education amongst Sighted Children of Blind parents

- Free distributionof school materials for Pre primary & Primary School going children.
- Educational Assistance in the form of Scholarship to the children studying from primary to higher education and vocational training.
- BPA also offers educational Assistance to College Going blind Students.
- This year, the free distribution of educational materials to the sighted children of visually impaired parents was held on Saturday 15th June, 2019, at the B P A office, Cottongreen. The educational materials such as School bags, Lunch Box, Water Bottle, Note Books, pencils, erasers, scale, sharpeners etc. were distributed free of cost. Mr Y D Zope, Vice President, MrKetan

Kothari, Hon. General Secretary, MrPurshottam Patel, Mr Ramesh Thakkr and Mr Nilesh Kulkarni members of the Executive Council were present on this occasion and distributed the kits to the students at their hands.

During this year 75 sighted children of 62 blind parents benefitted out of this project to the tune of Rs. 29,947/-.

The Note Books were sponsored by Mr Hitesh Mehta of H M Classes who has been sponsoring the same for the past 12 years through the kind courtesy MrPurshottam Patel. The Lunch Boxes and Compass boxes were donated by Mrs&MrBhaskarSalian through the kind courtesy of MrsSavitaZende. Through her efforts we have also received cash donations from Ms Pradnya Jayaprakash Bhogle. MsRatna Chowdhury, MsKiran Mahesh Rajpal and Mr Prasad Todankar. Water Bottles, scales, pencils etc. worth Rs 2,000/-were donated by Mr C A Patu, our Ex-Vice President.

The Association kept on record its sincere thanks to all the donors for their valuable assistance and appreciated the efforts of Mr Purshottam Patel and Mrs Savita Zende for procuring the donations for the Association..

Distribution of Scholarships:

The Association distributed scholarships to the sighted students of blind parents on Saturday, 16th November 2019, at our Office premises. Mrs. Anubha Dixit, President, Mr Y D Zope, Vice President, Mr Ketan Kothari, Hon. General Secretary, Mr Purshottam Patel and Mr Nilesh Kulkarni, Members of the Executive Council were present on the occasion and distributed the cheques at their hands. During the year 115 students of 83 parents were awarded scholarships to the tune of Rs.70,000/-.

Similarly the scholarships to the college going blind students were distributed at our office premises on Saturday, 18th January 2020. Mr Hiraman Shinde, Mr Mansing B Chavan, Mrs Archana Shinde and Mr Nilesh Kulkarni, members of Executive Council, were present on this occasion and distributed the cheques to the students at their hands. During the year 29 girls and 44 boys were awarded scholarships to the tune of Rs. 85,100/-. We have also forwarded the names of these 73 students to another Charitable Trust viz. Samarthanam for scholarships.

Thus under the educational programme, during the year Association spent a total amount of Rs.1,85,047/-. The entire educational expenses were met from the munificent donation received from BNP Paribas, under their CSR Scheme.

BPA-BPCL SCHOLARSHIP

During the academic year 2019-20, we referred 19 sighted school and college going wards of blind parents, to Bharat Petroleum Corporation Ltd., for scholarships. Due to some technical reasons at their end, the scholarship amount was not distributed till the end of March 2020. We were informed that the BPCL would The Association kept on disburse the amount in due course. record its sincere thanks to BPCL for their consistent support to our cause.

NEED-BASED FINANCIAL ASSISTANCE

Under this scheme, BPA offers partial financial assistance to needy blind persons to acquire household articles such as Cots, Mattresses, Gas connections, Cupboards, Kitchen Racks, Utensils etc. BPA also provides financial assistance to needy blind persons to meet unforeseen expenditure caused by fire, flood, building collapse, sudden death of earning member of the family etc. Total assistance of Rs 22,234/- was disbursed to 10 clients during the year.

HOUSE REPAIR

BPA extends a helping hand to the needy blind persons residing in hutments and dilapidated dwelling units to get their houses The help is given in the materials. During the year an amount of Rs. 5,000/- was provided to a blind person whose house had completely collapsed due to heavy rain and wind.

HELP THE AGED SCHEME

Under this scheme we give Rs. 500/- per month per person, to financially poor blind persons who have reached the age of 60 or older to meet part of their expenses for medicines, grocery, toiletries, clothes etc. This aid is provided at their doorsteps, which builds up good rapport with them. During the year, 17 males and 15females were assisted to the tune of Rs.1,88,500/-.

EQUIPMENT BANK

For last several years BPA has been running Equipment Bank for the blind. This is a unique schemeof its kind in Maharashtra. Special aids and appliances such as White Canes, Chess Boards, Playing Cards, Writing Slates, Signature Guides, Weighing Scales etc. are made available at highly subsidized cost to needy clients. During the year the materials worth Rs. 28,602/- were supplied to 113 poor and needy blind persons.

BPA THACKERSEY FUND FOR THE REHABILITATION & EMPOWERMENT OF BLIND WOMEN

BPA has established this benevolent fund for rehabilitation of blind women with kind courtesy of Thackersey Charitable Trust. During the year 2019-20, 32 blind women were assisted in their hour of need under our various schemes to the tune of Rs 1,23,940/-

HAWKERS' DAY:

The Hawkers' Day was celebrated on Saturday, 11th May 2019, at Kedarnath English High School, Nehru Nagar, Kurla (East), Mumbai, from 2.00 p.m. to 4.00 p.m. Lion MrDeepkRohra, the Trustee of Kedarnath School was the Chief Guest. participated in the function. The function was inaugurated by MrsAnubha Dixit, President. Thereafter MrKetan Secretary, briefed about our various Kothari, Hon. RESHIMBANDH PROGRAMME:

This year the sixth "Reshimbandh" Programme was conducted on Saturday, 17th August, 2019, at "Municipal School, Near" S" Bridge, Byculla, Mumbai, from 2.00 p.m. onwards. The main object of the programme is to give a chance to the visually impaired youth to exhibit their talents in various cultural programmes on the stage. The programme started by lighting the lamp jointly by MrsAnubha Dixit, President, MsSaiTambe and Ms. MeghnaErande of Storytel. The function was attended by around 100 people.

MsSaiTambe, of Storytel explained various advantages of Mobile App "Storytel" for the use of visually impaired people.. She said that at present more than one lakh recorded books are available in various other on this App in English as well as languages. MsMegnanaErande presented a programe with voice modulation. They charge a nominal amount of Rs. 299/subscription charges per month. However they offered that the first one month can be given free of charge on trial basis. has to Thereafter those who want to continue subscription charges. Afterwards she requested the audience to raise questions if they had any. Out of the 29 candidates, 12 persons were selected for their training programme. This was the fifth batch selected for training. On successful completion of the training programme, the candidates would be provided placements in different companies.

5 FREE DISTRIBUTION OF FOLDING CANES AND WEIGHING SCALES:

The Lions Club of Chembur and our Association had jointly organized a programme of free distribution of folding canes and weighing scales to poor and needy visually impaired people at our Office on Friday, 4th October, 2019, during the occasion of "Lions Service Week". The Progamme was organized through the kind courtesy of our Ex-Vice President, Mr C A Patu. The President and some of the Office Bearers of Lions Club of Chembur, MrKetan Kothari, Hon. General Secretary and MrPatu were present on the occasion. The Lions Club of Chembur donated 100 numbers of Folding Canes and 10 numbers of Weighing scales for distribution amongst the blind people. At this function, eight numbers of folding canes and three numbers of weighing scales blind people who were distributed free of cost amongst the present on this occasion, at the hands of the office bearers of Lions Club. The Association kept on record its gratitude to the Lions Club of Chembur and appreciated the efforts of MrPatu.

Mr Bihari N Shah, former President of our Association, tribute to Dr Vyas and shared his contribution in the field of Vyas was one of the founder members of the Association, in 1947. He continued to hold various positions of the Association till the year 1993, and thereafter he was the President Emeritus of the Association till the end of his life in the year 2010. Dr Vyas lived for 80 years out of which he dedicated about 63 years for working in the field of blind welfare activities. He was instrumental for a number of blind welfare activities not only with this Association but also with the National Association for the Blind, India, (NAB, India) which was established during the year 1952, around 5 years after the establishment of this Association. While working for NAB, India, he got an offer from an N G O based in U K known as the Royal Commonwealth Society for the Blind (presently known as "Sight Savers") where he was working as Asia Director. Though he was working with other Association, he continued to serve NAB, India, in his voluntary capacity. Through his initiative the NAB, India, had started the Talking Book Library, Braille Press, Training Centres for the blind and many more activities. He was always willing to mingle with the people from grass root level and help His name will them to find out solutions for their problems. always be written in golden letters in the field of blind welfare into consideration contributions for the blind, the Blind Persons' Association, Mumbai activities. has instituted an award in his memory to be given every year to one of the blind persons who has excelled in his/her abilities or services. This year the award was conferred on MrSagarHirajiPatil, a totally blind person who is a Post Graduate in Marathi Literature and thereafter he himself set up a company in the area of electronics and solar energy. Probably he is the first blind person in India, who acquired four patents in the area of electronics. In recognition of his outstanding achievement as an entrepreneur and innovator, a citation and Cash Award were presented to him at the hands of the Chief Guest, Mrs Vaishali Babu.

On this occasion we felicitated Mr ArvindNere, a visually challenged person, for his selfless and dedicated services in the field of blind welfare activities. Mrs Santa Narsian, former Hon. General Secretary and President of B P A, introduced Mr Nere to the audience in glowing terms. Mr Nere was felicitated at the hands of the Chief Guest with a letter of appreciation and a memento.

While addressing the audience, Mrs VaishaliBabu, said that she was very much impressed about our activities and services. She also appreciated the abilities and achievements of Mr SagarPatil in the field of electronics and solar energy in spite of his visual impairment.

Thereafter Mr Mohammed Raza, Member of Executive Council proposed the vote of thanks to the Chief Guest and all other participants for sparing their valuable time and making the programme a grand success.

After the award presentation function, a musical programme was performed by Mr Rajat Vijay Mishra and Team. The Programme was very much entertaining. The audience were delighted by hearing their songs. It was a memorable evening for the audience. The Association kept on record its sincere gratitude to the entire team for accepting our request and entertaining the audience, free of cost.

The programme concluded at 7.00 p.m. followed by National Anthem. All the participants were served with tea and delicious snacks.

Unfortunately on this occasion, one of our participants viz. MrMadhukarKokate, had slipped off and fell down to the river

nearby the picnic spot. He was immediately taken out and rushed to the nearby Medical centre for preliminary treatment and subsequently taken to Shatabdi Hospital at Kandivali for further check up and observation.
